All shipping expenses will be the responsibility of the Mare Owner. Contact Heide's Veterinary Service for an estimate of shipping cost from their facility to the veterinary facility of your choice.

All breeding expenses for the mare are the responsibility of the Mare Owner.

### **Terms and Conditions**

The frozen semen will ONLY be inseminated into the designated mare in this contract.

**Twins:** In the event the mare double ovulates and 2 embryos are found on a pregnancy ultrasound, the Mare Owner will undertake to ensure the safety of the mare as advised by their veterinarian. If twins are born as a result of double ovulation, a second stallion service fee will not be required.

**Embryo Transfer:** In the event the mare double ovulates and 2 embryos are flushed, a second stallion service fee will not be required.

The Mare Owner is responsible for all associated veterinary fees to ensure the mare is healthy and in sound breeding condition. A breeding soundness exam is recommended and may include a current uterine culture and cytology showing the mare to be free of infection. A uterine biopsy may be recommended by the Mare Owners' veterinarian to help evaluate for sound breeding condition.

The Mare Owner is responsible for the condition of the mare and bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees that the Stallion Owner, keeper, Agent, or any person(s) employed by or associated with the Stallion Agent will not be held responsible for any and all damages associated therewith.

Should the mare become or be determined to be unfit for breeding, the Mare Owner may request to change the mare. The Mare Owner must have prior approval from the Stallion Agent for the semen to be used in a mare different than the one designated in this contract. Additional stallion service fee may apply (see below).

No refunds of the Stallion Service Fee will be given.

**Live foal guarantee** is defined as a single foal that is born alive, stands, and nurses, and survives for a period of at least 48 hours from the time of its birth. If a foal is not produced as defined herein, the Mare Owner is entitled to a rebreeding of this same stallion.

Should the foal not survive as defined the Mare Owner is to inform the stallion agent promptly and provide a veterinary certificate confirming the issue, such as aborted or stillborn foal.

The Mare Owner is responsible for all associated re-breeding costs.

**Re-breeding:** This stud fee offers 2 re-breeding attempts in the immediate and following breeding season. Additional re-breeding beyond the 2 may be considered for an additional fee of \$500 per straw.

Stallion Agent or Heide's Veterinary Service is not responsible for any shipping delays once the semen tank/dry shipper is charged, stocked and under care and control of the shipper/courier.

A veterinary letter/certificate for the first insemination attempt(s) may be requested by the Stallion Agent to validate the quality of the frozen semen upon thawing and/or the breeding soundness of the mare.

Mare Owner will be responsible for additional shipping/courier fees for additional doses and all mare expenses for original mare and substitute mare.

Failure to conceive does NOT constitute breach of contract nor entitle the Mare Owner to a partial or full refund. Reproductive viability of the mare is the Mare Owner's sole responsibility.

Failure of successful semen thaw (semen appears dead upon thawing) does NOT constitute breach of contract nor entitle the Mare Owner to a partial or full refund. Frozen semen requires special handling. This semen collection and freezing was proven viable prior to export from Ireland. Semen report is available.

I, the undersigned, do hereby certify that I am the Mare Owner/Lessor named herein and have the authority to enter into this contract, as witness by my signature. I also certify that I have read and understand this contract and fees. Upon approval of this contract application, I hereby agree to the terms and conditions set forth in this breeding contract. This contract is binding upon both parties when signed and if disputed, will be governed by the laws of Alberta, Canada.
